**RE: Urge Congress to Enact Legislation to Ensure Senior Access to Essential Pharmacist Services Now**

Dear Secretary Becerra, Mr. Zients, Mr. Perez, and Ms. Tanden,

In the diverse communities we represent across the country, Americans rely on pharmacists to access critical care and services to manage their health and wellbeing. For those we serve, the pharmacy remains a safe haven to access critical medications, services, and support. Unfortunately, current federal barriers threaten patient access to essential pharmacist services for millions of America's seniors. On behalf of the communities we serve – including Medicare beneficiaries, rural communities, patients living with chronic and complex conditions, caregivers, and others with limited access to health care – **we urge you to call on Congress to support and enact the Equitable Community Access to Pharmacist Services Act (H.R. 1770, S. 2477) before the end of the calendar year.** This bipartisan legislation will ensure seniors maintain access to essential pharmacist services for some of the most challenging infectious disease threats facing our communities and strengthen our nation's public health response in the process.

Pharmacists are the most accessible health care provider for many communities. Nine in ten Americans live within five miles of a pharmacy, and patients visit their community pharmacist twice as frequently as they visit primary care physicians. For seniors, pharmacists serve as a trusted source of care and support, often providing the first point of contact for medication-related concerns and preventing or mitigating the impacts of infectious disease. Pharmacists assist with medication adherence, identify barriers that may prevent patients from taking their medications as prescribed, and implement strategies to improve adherence rates. Pharmacists also play a vital role in delivering immunizations, providing flu shots and other vaccinations to seniors to protect them from preventable diseases.

Pharmacists play a crucial role in ensuring access to quality care for seniors in rural America, who often have limited care options and require additional support to manage complex medical conditions. In rural

areas, Medicare patients have an average of 14 pharmacy visits per year compared to only 5 primary care encounters.

**We urge you to call on Congress to support and advance the Equitable Community Access to Pharmacist Services Act (H.R. 1770, S. 2477) Part B and ensure pharmacists can continue to protect seniors from the threat of COVID-19, influenza, RSV, strep throat, pneumococcal, and hepatitis B.**

We commend the Biden Administration for your ongoing efforts to improve the health and well-being of America's seniors and appreciate your leadership and support on this critical patient issue.
